BACKGROUND

Proactive environment and safety management measures are now embedded in the day-to-day existence of the Australian oil and gas industry.

The company that wins an APPEA Safety or Environment award will be a visible example of these principles being “lived” and serve as a role model for others in the industry.

The following information is a guide for the content of submissions and shortlisted applications.

APPEA PRINCIPLES OF CONDUCT

APPEA members must comply with the requirements of all laws and regulations and also demonstrate performance consistent with the industry’s overall objective of maintaining a social licence to operate.

Our members will continuously strive to improve safety and environmental performance in ways that:

- ▶ Protect people and the environment through the responsible management of operations and their risks and impacts;
- ▶ Incorporate risk management strategies based on sound science, to the application of new technologies and industry practices;
- ▶ Engage constructively with government, industry and stakeholders to develop appropriate principles and objective-based standards.



COMPANY AWARD

THE COMPANY AWARDS RECOGNISE OUTSTANDING SAFETY OR ENVIRONMENTAL PERFORMANCE ACROSS AN ORGANISATION FOR THE PREVIOUS CALENDAR YEAR. THIS IS A COMPETITIVE PROCESS WITH APPLICATIONS RANKED BY AN ASSESSMENT PANEL AGAINST THE AWARDS CRITERIA.

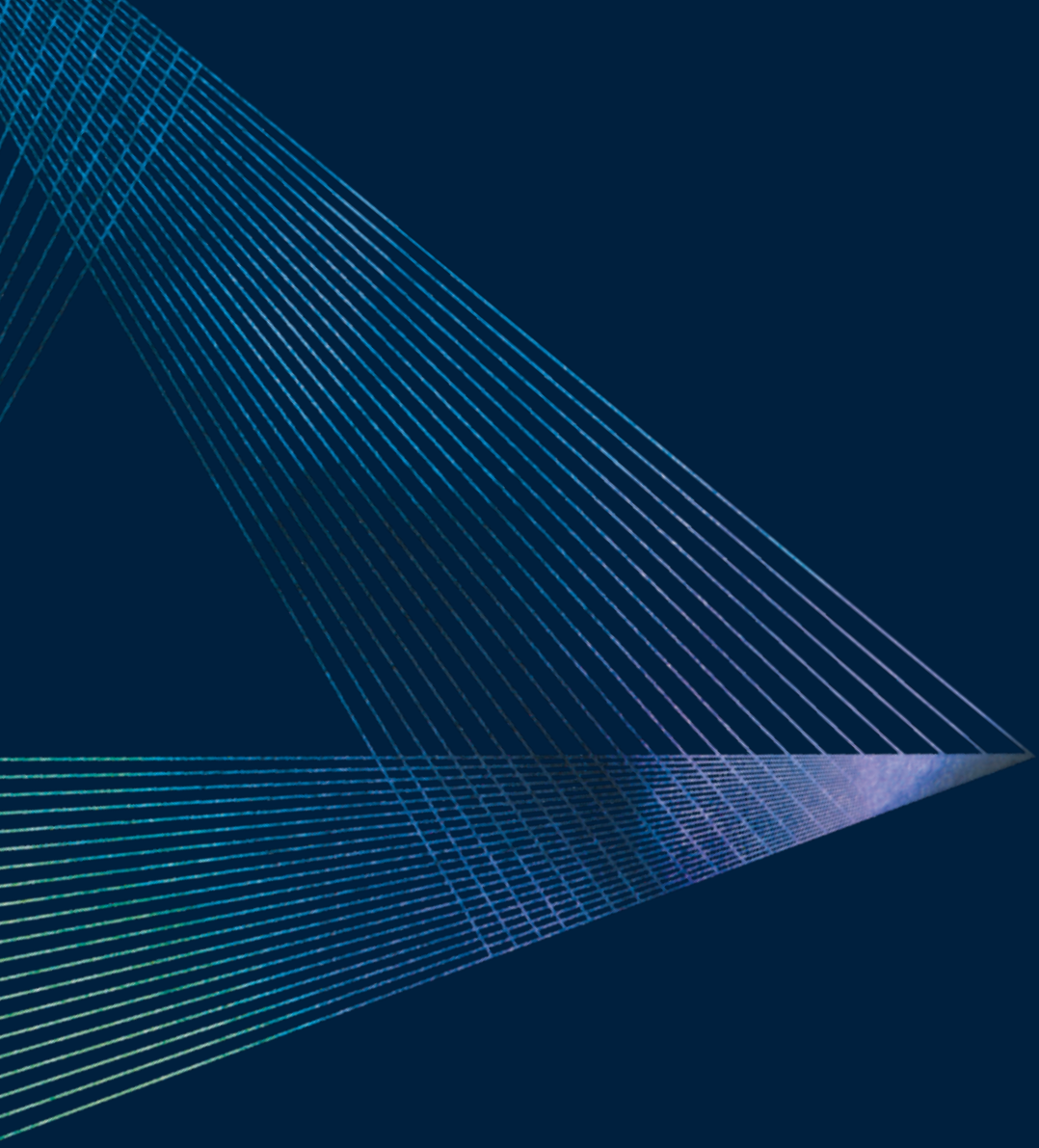

TERMS AND CONDITIONS

- ▶ Applicants must be members of APPEA.
- ▶ There is no limit to the number of nominations a company can submit, however the same submission cannot be submitted to cover more than one category.
- ▶ A project that has previously received an APPEA award will not be eligible for future submissions in the same category.
- ▶ Recent projects will be given priority.
- ▶ No major accidents or loss of life for the submission period
- ▶ The provision of misleading information or omission of important information will result in the submission not being considered by the assessment panel.
- ▶ The assessment panel may request further information to assist with consideration of the award winners.
- ▶ APPEA has complete discretion in deciding the outcomes of the awards.
- ▶ APPEA retains the right not to award a safety and/or environment excellence award in any given year should the submissions not warrant such after consideration by the assessment panel.
- ▶ APPEA is not obligated to provide feedback on individual submissions.
