APPEA's full member companies explore for and produce Australia's oil and gas resources. These companies currently account for an estimated 98 per cent of the nation's petroleum production.

In addition, APPEA also represents many associate member companies that provide a wide range of goods and services to industry.

APPEA assists its members by working with the Australian, state and territory governments to ensure that the regulatory and commercial framework promotes investment and maximises the return to the Australian community from finding and developing the nation's oil and gas resources.

APPEA aims to secure conditions that help its member companies operate safely, sustainably and profitably. APPEA also works to increase community and government understanding of the upstream petroleum industry by publishing information about its activities and economic importance to the nation.

The association regularly conducts forums for exchanging ideas and helping develop the industry's policy positions.

There are three types of APPEA membership:

- full member
- associate member
- honorary life member.

An associate member of APPEA must be:

 a company with bona fide interests in the objectives, influence and interests of APPEA

or

 a party that provides services in the ordinary course of business to full members of APPEA.

There are three categories of associate membership:

Category 1 Small companies, government agencies, educational institutions and small service/supply providers.


Category 2 Service and supply organisations including financial/commercial, legal, environmental, and technical support service companies, equipment and/or hardware suppliers, data processors and on-shore transport and storage.

Category 3 Field operation companies including EPCM contractors, drilling, seismic, marine and other field service companies.

benefits of associate membership



Membership of APPEA enables you to keep up-to-date with policy and legal changes that can directly or indirectly affect your business.

APPEA members receive information and updates on APPEA's advocacy work and industry news through the *APPEA Members' Report, Flowline* and other electronic newsletters, and the annual report.

APPEA members also receive alerts and preventative advice on critical workplace safety issues.

APPEA associate members can attend member-only forums organised by the association throughout the year, including the annual general meeting.

Member-only forums, such as the Members' Lunch, are also held as part of the annual APPEA Conference and Exhibition.

The association's Tax and Commercial Conference, a key biennial forum addressing commercial issues affecting the petroleum exploration and production industry, is another member-only event.
